THINK LONG TERM....YEARS down the road


3. The Strategies

GOALS

CSC 'goals' should reflect each of our priority areas and describe the impact CSC wants to have on the "whole" child in Leon County.

- 4. Young People Successfully Transitioned to Adulthood.

The end goal is to ensure equitable access to high-quality services and resources for young children, prenatal to age five, and their families.




